# AMENDMENT NO. 1 TO PC-001-T-2020 (Oasis Consulting Services)

THIS AGREEMENT is made this day of 2022 in the Territory of the United States Virgin Islands, by and between the Virgin Islands Waste Management Authority, 3200 Demarara, St. Thomas, VI 00802 (hereinafter referred to as the "Authority") Oasis Consulting Services, at 45 Woodstock Road St., Rosewell, GA 30075.

#### WITNESSETH:

WHEREAS, the Authority was in need of a Contractor to provide Professional Engineering and Environmental Consulting Services on a "Task Order" basis; and

WHEREAS, on the strength of the Contractor's expertise in the business of Engineering and Consulting Services, the parties entered into Professional Services Contract No. PC-001-T-2020 on March 24, 2020; and

WHEREAS, the Authority is in need of continued services for the consultation, design and construction oversight of various projects, in accordance with the original Scope of Services set forth in Addendum No. I (Scope of Services), attached to the original contract; and

WHEREAS, the Contractor represents that it has provided and is willing and capable of providing continued consulting services as set forth in Addendum I of the original contract as well as such additional services as required.

NOW, THEREFORE, it is agreed by and between the parties hereto, that Professional Services Contract No. PC-001-T-2020, between the Authority and the Contractor is hereby amended as follows:

#### 1. SERVICES

Contractor shall continue to provide Professional Engineering and Environmental Consulting Services on a "Task Order" basis.

#### 2. TERM

The term of Professional Services Contract No. PC-001-T-2020 shall be extended for one year from the date of expiration of the original contract on, March 24, 2022, and shall terminate on May 31, 2023.

### 3. COMPENSATION

This Amendment No. 1 shall not alter the budget and price of the Contract No. PC-001-T-2020 ADDENDUM II.

## 4. GENERAL APPLICABILITY

This Amendment No. 1, inclusive of the terms and the provisions set forth herein, shall be incorporated into the Contract by reference, and shall become an integral part thereof. In all other respects, the Contract, as amended, shall remain in force and effect.
